To be voted on by the public and awarded after the completion of the exhibition.

Sections

- 1. PAINTING** 1st Prize: **\$150**, 2nd Prize: **\$50**
Any painting medium, including oils, acrylics, watercolour, gouache, etc.
- 2. DRAWING** 1st Prize: **\$150**, 2nd Prize: **\$50**
Any drawing medium, including pencil, pen, pastels, inks etc.
- 3. PRINT-MAKING** 1st Prize: **\$150**, 2nd Prize: **\$50**
Any print-making technique, including linocut, etching, etc.
- 4. SCULPTURE** 1st Prize: **\$150**, 2nd Prize: **\$50**
Any 3D artwork, any materials.
- 5. "OUR PLACE"** 1st Prize: **\$150**, 2nd Prize: **\$50**
Any artwork, using any medium which reflects a sense of 'belonging' to the Gunnedah area, including Aboriginal art works.
- 6. CREATIVE POTTERY** 1st Prize: **\$150**, 2nd Prize: **\$50**
Any ceramic work, including hand-built and thrown techniques.
- 7. NOVICE** 1st Prize: **\$ 50**, 2nd Prize: **\$ 20**
Any subject, any medium. Artist should not have won an art prize previously.
- 8. UNDER 18 YEARS** 1st Prize: **\$ 50**, 2nd Prize: **\$ 20**
Any subject, any medium. Artist must not be over 18 years of age at the time of entry.
**Please note that this prize is intended for older children, younger children can enter the CHILDREN'S ART section in the Pavilion schedule.*

DELIVERY OF ARTWORKS: **Thursday, 20 April 2017**. Between 10am - 1pm at the Art & Photography Pavilion in the Showground. Prior to this time, artworks can be delivered to George Avard Rural Property Sales at 201 Conadilly Street, Gunnedah during office hours.

EXHIBITION OPENING: **Friday, 21 April 2017 at 6pm**, Art & Photography Pavilion.

COLLECTION OF ARTWORKS: **Sunday, 23 April, 2017**. Between 10am - 12pm at the Art & Photography Pavilion. After this time, the artworks can be collected from George Avard Rural Property Sales during office hours.

Entry Fees

Sections 1 - 6, entry fees are \$5 per artwork and **Sections 7 - 8**, entry fees are \$1 per artwork.

Sale Information

Artwork does not have to be for sale. If you would like to sell your artwork during the exhibition a commission rate of 20% will be apply to all sales. Please consider your sale price - include the commission amount in your price listed in the entry form as the commission will be based on the indicated sale price.

Conditions of Entry

1. Works must be the original work of the entrant and not previously exhibited at the Gunnedah Show.
2. Each entry to have name, address, title, section and price (or NFS) clearly indicated on reverse or appropriate area not visible to the viewer for 3D artworks.
3. All works must be dry, mounted or framed with hanging equipment attached. Works not ready for hanging will not be included in the exhibition. Artworks must not be too large for hanging, please keep all work under 1.25m². Sculptures and ceramics must have a stable base or similar for display purposes.
4. No exhibit can be entered into more than one section.
5. All entries will be judged but the Show Society reserves the right to withhold any work considered unsuitable for hanging and the judge's decision is final.
6. The Show Society reserves the right to have any entry reproduced in press or telecast.
7. All possible care will be taken with works, but all transport and insurance costs are to be met by the entrant. The Show Society will not accept any liability for loss or damage in transit, at drop off or collection points, or while on exhibition.
